The Superintendent, Santipur S.G. Hospital, Santipur, Nadia invites sealed tenders from eligible bidders for supply and installation of two (2) numbers of 52" LED television sets at Santipur State General Hospital, Santipur, Nadia. The tender process will be of two bid system (Technical and financial). The Specification of those two LED televisions should be as under:

1. The LED Television set must be of 52" size.
2. The LED Television Set must be of commercial category having capacity of operating 24 hours or at least 16 hours per day constantly.
3. The LED Television Set should have the internal storage of at least 4 GB and inbuilt media player so as to eliminate the requirement of separate DVD players.
4. The LED Television Set should have the "Event Scheduler" to run and stop the preloaded IEC content in a pre-schedule manner. This will also ensure proper rest to the Television set.
5. The LED Television Set should have the USB Out and RJ 45 connectivity.
6. The LED Television Set should have the Energy Star Compliance of maximum rating.

: TERMS AND CONDITIONS:

The rates must be quoted with VAT as per format. The rates quoted should not be more than MRP in any case.

EARNEST MONEY DEPOSIT (EMD):

An earnest money of Rs.5000/- (Rupees Five Thousand Only) for participation in the tender is to be submitted with the tender by Demand Draft in favour of "Santipur S.G.H Rogi Kalyan Samity", Santipur, Nadia.

The tender should submit the tender in following two bids:

1. Technical Bid: -

It should submit the self-attested photocopy of the following documents.

1. PAN Card.
2. Sales Tax/VAT Registration Certificate.
3. Trade License in the name of the concern.
4. P. Tax Details.
5. I.T. Clearance Certificate.
6. Experience and past performance on similar contracts in Govt. Department/PSUs for last two years.
(Filled up Annexure-A for apply to participate in this bidding)

2. Financial Bid: - It should have only prices/rates inclusive of all taxes quoted by the tenderer. Financial Bid of the tender will be opened if he is found qualified in technical bid.

1. The individual signing the tender or any document forming a part thereof on behalf of proprietor/Company/firm shall be responsible for producing an proper authorization or power of attorney for the same.
2. The rates of the tender must remain valid for a period of one year with effect from the date of acceptance of the tender and may be extendable, if required, on mutual agreed terms.
3. The tendered should give warranty against any item supplied by them and replace the defective item(s) at their own cost.
4. The Tender Selection Committee nominated by the Competent Authority to assess eligibility shall carry out the evaluation of bids.
5. The EMD furnished with the tender will be retained upto signing the supply contract or 15 days after final selection whichever is earlier.
6. In the event of breach/violation or contravention of any terms and conditions contained herein by the selected vendor, the security deposit shall be forfeited.
7. Order will be placed with the selected bidder as per requirement of this hospital and supply and installation is to be made within seven days from the date of the order.
8. Items supplied by the selected vendor should strictly conform the specification given above.

9. At the time of signing supply contract, a security money @ 2% of the contract value(supply) in the form of Bank Guarantee valid up to 12 months payable on any nationalized Bank/ schedule bank to be furnished/deposited by the vendor. The security deposit will be refunded after expiry warranty period. But, the security deposit will be liable to forfeiture without prejudice to any other action in the event of failure or refuse to supply the items at quoted rate and/or within the period mentioned in the supply contract and/or according to contracted specification or quantity. Again, if the supplier/vendor fails to replace/attend the damage item(s) /out of order, security deposit will be liable to be forfeited by the authority.
10. Sealed Tenders in Annexure-A along with relevant documents shall be received during office hours in the Box placed in the office of the Superintendent, Santipur SG Hospital, Santipur, Nadia.
11. The Envelop should be superscripted as "Tender for two (2) numbers of 52" LED television sets at Santipur State General Hospital,".
12. The decision of the **"Tender Selection Committee"** is final and in the matter of selection of tender, the **"Tender Selection Committee"** reserves all the right to accept or cancel/reject any or all tenders wholly or in part without assigning any reason. The **"Tender Selection Committee"** is not bound to accept always the lowest rate.
